Local Law Policy No 19 (Regulated Parking) adopted 12/05/99, incorporating Regulated Parking (Amendment) Subordinate Local Law (No 1) 2002 adopted 25/09/02.

This Local Law Policy is to be read with Local Law No. 19 (Regulated Parking).

Citation

1. This local law policy may be cited as Local Law Policy No. 19 (Regulated Parking).

Traffic area (To be read with Section 4(1) of the Local Law)

2. Pursuant to the Traffic Act, 1949 and Local Law 19 (Regulated Parking), the whole of the Redland Shire Council is hereby declared to be the Redland Shire Council Traffic Area.

Regulation of parking (To be read with Section 5 of the Local Law)

3. Any parking within the Redland Shire Traffic area, whether on roads or off-street areas as defined in Schedule 1 attached to this local law policy, maybe:
 - (a) restricted at all times, or for specified times,
 - (b) prohibited at all times, or for specified times,within the areas specified and times indicated, by official traffic signs.

Regulated parking on roads (To be read with Section 8 of the Local Law)

4. Unless otherwise signposted parking on roads and off-street regulated parking areas shall be unlimited within the Traffic Area at all times.

Off-street regulated parking (To be read with Section 9 of the Local Law)

5. The areas of land (including any structure thereon) described in Schedule 1 appended to this Local Law Policy are hereby prescribed to be Off-Street Regulated Parking Areas and shall be signed as such.

Classes of persons to whom permits may be issued (To be read with Section 19 of the Local Law)

6.
 - (1) This section specifies the classes of persons to whom parking permits may be granted.
 - (2) A parking permit may be granted to a person if —
 - (a) the person resides in a residence —
 - (i) situated on a section of road in circumstances where parking immediately adjacent to the residence is regulated by time; and
 - (ii) which is not situated in a no parking permit area; or
 - (b) the person is the registered owner of land —
 - (iii) situated on a section of road in circumstances where parking immediately adjacent to the land is regulated by time; and
 - (iv) which is not situated in a no parking permit area.
 - (3) For the purposes of this section —
 - (a) **“freehold land register”** has the meaning given to that expression in the *Land Title Act 1994*¹.
 - (b) **“residence”** means a building, or part of a building that is —
 - (i) fixed to land; and
 - (ii) designed, or approved by a local government, for human habitation by a single family unit; and
 - (iii) used for residential purposes.
 - (c) **“no parking permit area”** includes each area hatched in black on the maps included in Schedule 2 and marked with the letters “A” to “E” inclusive.

¹ In the *Land Title Act 1994* “freehold land register” means the freehold land register kept under that Act. This is a working document only and is not meant for legal proceedings. - (d) **“registered owner”** has the meaning given to that expression in the *Land Title Act 1994*².

² In the *Land Title Act 1994* “registered owner” of a lot means the person recorded in the freehold land register as the person entitled to the fee simple interest in the lot.

Doig Street off street carpark (E)	between Middle Street and Queen Street, Cleveland
Doig Street off street carpark (W)	between Queen Street and Middle Street, Cleveland
Unnamed Lane	between Queen Street and Doig Street off street carpark, Cleveland
Waterloo Street off street carpark	between Middle Street and Queen Street, Cleveland
John Street off street carpark	between Queen Street and Russell Street, Cleveland
Wynyard Street off street carpark	between Middle Street and Queen Street, Cleveland
Queen Street off street carpark	between Wynyard Street and Water Street, Cleveland
Queen Street off street carpark	between Water Street and Bloomfield Street, Cleveland
Shore Street off street carpark	between Wynyard Street and Waterloo Street, Cleveland
Toondah Harbour off street boat trailer area	Middle Street, Cleveland
Wellington Point off street car and boat trailer park	Main Road, Wellington Point
Dollery Road off street carpark	between Old Cleveland Road and Noeleen Street, Capalaba
Service road off Old Cleveland Road	between Old Cleveland Road and Banfield Lane, Capalaba
Victoria Point off street car and boat trailer park	Masters Avenue, Victoria Point
Weinam Creek off street car and boat trailer park	Banana Street, Redland Bay

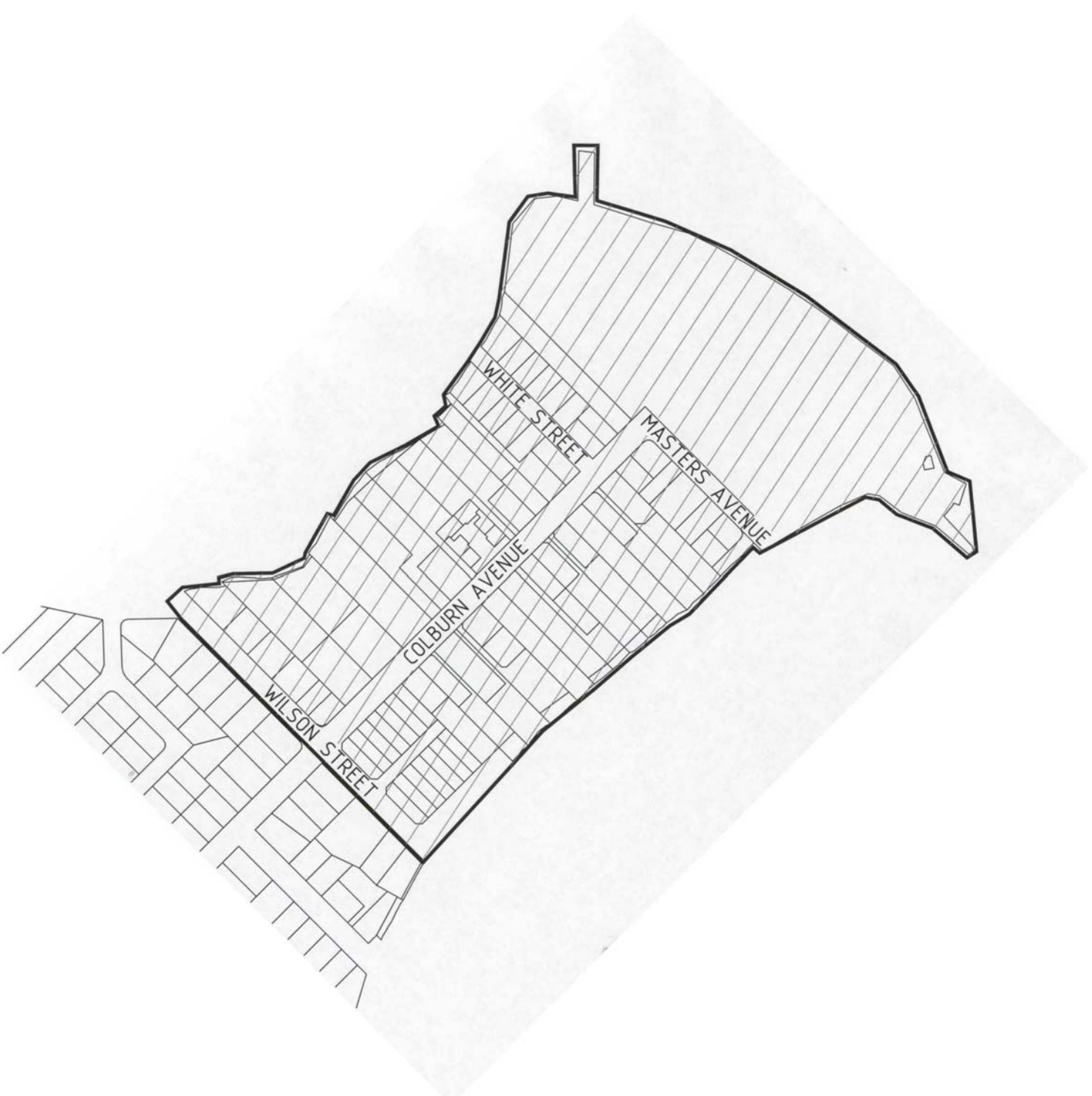

no parking permit area



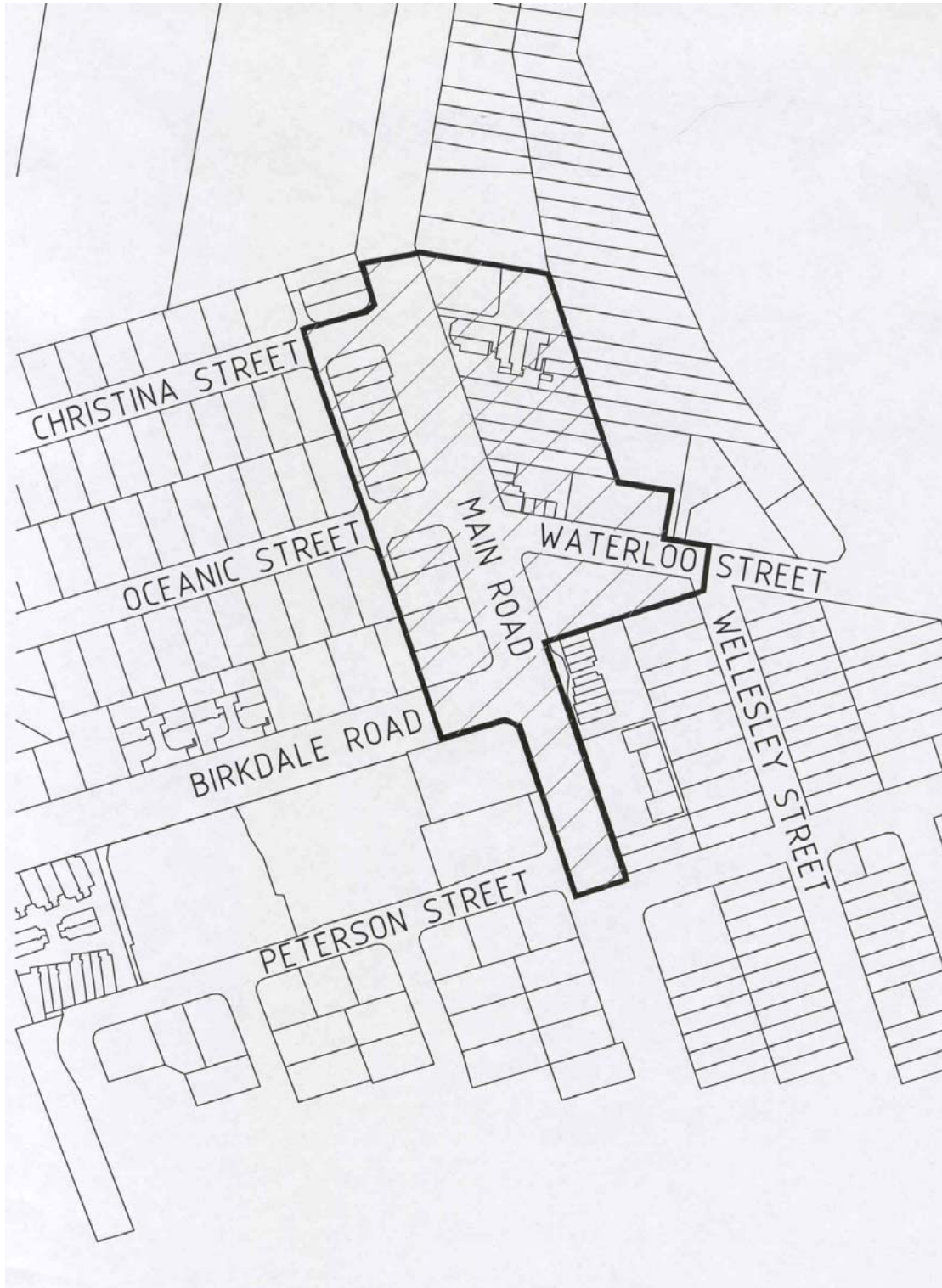
