Local Government Act 2009

Redland City Council ("Council") has proposed to make:

1. Redland City Council Roads (Amendment) *Subordinate Local Law (No. 1) 2011 (the "Roads Amendment Subordinate")* which amends *Subordinate Local Law No. 21 (Roads)*; and
2. Redland City Council Regulated Parking (Amendment) *Subordinate Local Law (No. 1) 2011 (the "Regulated Parking Amendment Subordinate")* which amends *Subordinate Local Law No. 19 (Regulated Parking)*; and
3. Redland City Council Animal Management (Amendment) *Subordinate Local Law (No. 1) 2011 (the "Animal Management Subordinate")* which amends *Redland Shire Council Subordinate Local Law No. 2 (Animal Management) 2007*,

(collectively the "3 Proposed Subordinate Local Laws").

The local law which authorises the making of each of the 3 Proposed Subordinate Local Laws is as follows:-

- (a) *Local Law No. 21 (Roads)* authorises the making of the Roads Amendment Subordinate;
- (b) *Local Law No. 19 (Regulated Parking)* authorises the making of the Regulated Parking Amendment Subordinate;
- (c) *Redland Shire Council Local Law No. 2 (Animal Management) 2007* authorises the making of the Animal Management Subordinate.

The purpose and general effect of the Roads Amendment Subordinate is to amend *Subordinate Local Law No. 21 (Roads)* to add a schedule of off-street regulated parking areas, to implement the provisions of the local law controlling the parking of unregistered vehicles on off-street regulated parking areas.

The purpose and general effect of the Regulated Parking Amendment Subordinate is to amend *Subordinate Local Law No. 19 (Regulated Parking)* to update the schedule of off-street regulated parking areas.

The purpose and general effect of the Animal Management Amendment Subordinate is to amend *Redland Shire Council Subordinate Local Law No. 2 (Animal Management) 2007* by updating the schedule of dog off-leash exercise areas.

Council invites written submissions by any person in support of, or objecting to, the 3 Proposed Subordinate Local Laws for a 42 day period commencing on **13 December 2011** and ending on **24 January 2012**.

During the period for receipt of submissions, copies of the 3 Proposed Subordinate Local Laws are open to inspection on Councils' website www.redland.qld.gov.au and at Council's Customer Service Centres located at Cnr Bloomfield and Middle Streets Cleveland and Capalaba Place, Noeleen Street Capalaba. Copies of the 3 Proposed Subordinate Local Laws may be purchased from Council's Customer Service Centres at a cost as follows:

1. Redland City Council Roads (Amendment) *Subordinate Local Law (No. 1) 2011* - \$3.00;
2. Redland City Council Regulated Parking (Amendment) *Subordinate Local Law (No. 1) 2011* - \$3.00; and
3. Redland City Council Animal Management (Amendment) *Subordinate Local Law (No. 1) 2011* - 40¢.

Submissions must be received on or before **24 January 2012** stating:

- (a) the grounds of the submission; and
- (b) the facts and circumstances relied on in support of the grounds.
