

# Redlands Coast AdventureFest Fun Day

## Competition Terms and Conditions

1. Redland City Council ABN 86 058 929 428 of Corner Middle and Bloomfield Streets, Cleveland, Queensland ("RCC") is conducting a series of surveys regarding the Christmas on Redlands Coast program. As part of this survey entrants have the option to include their contact details to go into the draw to win 1 of 3 prizes.
2. The competition will commence on Saturday 17 May at 10:00am and conclude on Saturday 17 May at 4.30pm ("the Competition Period").
3. To be eligible, entrants ("Competition Entrants") must submit a completed competition entry including contact details in person at the Redlands Coast Visitor Information stall at the AdventureFest Fun Day.
4. Competition Entrants must be 18 years of age or older to enter the competition or seek approval and consent from their parent/guardian prior to entering on their behalf. 9. The judges' decision is final, and no correspondence will be entered into.
