Brosnan Drive footpath

In July, I received a petition from residents requesting footpaths for Barber and Brosnan Drives in Capalaba. Through previous representations from a number of residents, I had already managed to have some footpaths funded for Brosnan Drive in our current budget. The petition has now supported that allocation of funds and future considerations for Barber Drive as follows:

- 2009-10 Stage 1 Brosnan Drive \$38,000
- 10 Year Capital Works Program Stage 2 Brosnan Drive \$85,000
- 10 Year Capital Works Program Barber Drive \$78,000.

Traffic calming devices

Another thank you to residents who presented me with a petition which assisted me in supporting their safety concerns for speeding in their streets. Traffic calming devices have now been installed in Willard Road and Elmhurst Street Capalaba. Please remember that speeding and hooning is a police matter and it is important you report these incidents to your local police for enforcement.

New state SEQ water restrictions for Redlands

It is important for you to understand the upcoming changes to water restrictions. Under direction of the Queensland Government, from December 1, the whole south-east Queensland region will have consistent rules for water use for the first time. This means Redland City Council must fall in line with other regions.

Council budget

Earlier this year, I presented a petition by a concerned resident pensioner to investigate the issues faced by single pensioners and pensioners in general in affording the cost of their rates. This representation assisted Council's decision to increase the concession by eight per cent for full and part pensioners. Full pension concessions increased from \$300 to \$324, and part pension concessions are now \$162. Thank you to Faye who walked the streets of Capalaba to gather signatures to support the concerns of pensioners in Redlands. I will continue to represent these concerns in future budgets.

Redland City Council provides financial assistance to support local community organisations to undertake projects that will benefit the Redlands community. These grants cover arts and cultural heritage, environment, community development, enterprise development, sport and recreation. All grants are made on a one-off basis.
