

# News from your Local Councillor Cr Peter Mitchell

### Dear resident

A development application has been lodged for a mixed-use development comprising aged-care accommodation and commercial, retail and community facilities at 4-10 Doig Street, Cleveland.

The proposed development will provide five levels of aged-care accommodation for the Redlands ageing population, as well as 186 basement and ground-level car parks, and 2993sq m ground floor retail, medical and lifestyle amenities.

Ours is the fastest ageing community in South-East Queensland with Census data predicting there will be 52,748 people aged 65 and above in the city by 2031, making facilities such as this a necessity.

Lodged by aged-care provider Vacenti, the application is for a development which meets the needs of the community, creates local jobs and helps to revitalise the Cleveland CBD.

The facility is expected to provide employment for about 110 aged-care



professionals and 50 retail staff, and will have a significant spin-off for other businesses in the area.

The site will continue to be used as a carpark for at least another 12 to 18 months while the plans are finalised and necessary approvals obtained.

Vacenti was awarded bed licences for the proposed development in the last Aged Care Approvals Round by the Commonwealth Government Department of Health in May last year. Plans for the aged-care suites include hotel-style service designed to suit the safety, comfort, privacy and independence needs of residents, along with 24-hour qualified nursing care and on-site health and wellbeing services.

Council transferred the site to the Redland Investment Corporation in 2013 and it is facilitating the sale to Vancenti under plans to revitalise the CBD.

# Addressing Cleveland parking and transport

Council is continuing to work on complementary strategies aimed at addressing parking and transport issues in the Cleveland CBD.


One is an overarching city-wide strategy that will guide the direction and timing for future transport projects across the Redlands. The second is specifically aimed at improving the accessibility and walkability of the Cleveland centre. This has already involved early consultation, including workshops and a survey of what the community values most in our CBD.

Community input is essential for Council to get this right and, as such, residents and business owners are invited to make submissions to help inform these strategies.

Broader community engagement will begin on the Redlands Transport Strategy once a draft has been compiled and endorsed by Council.

## Toondah Harbour project to proceed to next stage

The Federal Government recently announced that the proposed Toondah Harbour Priority Development Area development is a "Controlled Action", allowing the project to proceed to the Environmental Impact Statement (EIS) phase.

This decision follows the unveiling of Walker Group's updated proposed masterplan for the project, which incorporates a number of new initiatives and takes in feedback from leading environmental and wetland experts, the public and Federal Government. Walker Group lodged a new referral with the Federal Government to incorporate the new initiatives in early June 2018. The Federal Government's decision to declare the proposed project a "Controlled Action" is an important milestone. It also is an important step for the community and the beginning of a process that will include ongoing community engagement and consultation by Walker Group.

The EIS phase will take approximately 12 to 18 months and will address all potential social, economic and environmental impacts of the proposed development during its construction and operational phases. Environmental, construction and traffic impact management plans will be developed as part of this process.
