Toondah Harbour update

The Commonwealth Minister for Environment and Energy Josh Frydenberg gave the green light on 9 June 2017 to progress the environmental impact assessment for the Toondah Harbour project in Cleveland.

Walker Group will now be able to take the application to the next stage of the process, which is to have the science tested through an environmental impact assessment.

The project will require innovative design, engineering, sustainability and environmental responses to deliver a world-class gateway that will better connect residents and visitors to the diverse coastal experiences and natural attractions of Moreton Bay and North Stradbroke Island.

The project will now be assessed under the Commonwealth Environment Protection and Biodiversity Conservation Act 1999 (the EPBC Act) for a decision. The Minister will identify the precise method and timing of the assessment in due course.

More information about key dates for the consultation during the environmental impact assessment phase will be made available to the community.

The scale and layout of the current proposal is preliminary and will be tested during the environmental assessment process. All community concerns also will need to be thoroughly tested and managed during this process.

The critical detail we all require will only be determined after full assessment under the EPBC Act. The widely accepted need to upgrade Toondah Harbour has been spoken of for more than 40 years but with no suitable result. I believe our community deserves to see this opportunity tested and the current assessment process completed. It is only then that we can analyse and balance all the genuine impacts and benefits for the greater good.

Amity erosion emergency measures - September 2017

A significant erosion event occurred in early September, causing concern for a property owner adjacent to Council land along the northern extent of Amity Point in the vicinity of Millers Lane.

Council reacted quickly, practically and legally to remedy this situation on Council land, resulting in 42 truckloads of rock being placed and other civil works to stabilise the affected area.


Council continues to work with the State Government, QYAC, reference groups and other agencies to finalise the Amity Point Shoreline Erosion Management Plan (SEMP) which will outline and define ongoing management strategies for the coastline in the Amity Point area.

Council officers are hopeful of presenting the SEMP strategy to the community and Council in the next 12 months.
