Dear resident of Division 8

Following my last newsletter that featured our ever faithful family dog, I would like to thank residents for the feedback and follow up. It has been amazing - we really are a pet loving community.

There were many follow-up questions, particularly about cat laws, and it is clear that wandering cats and dogs being walked off-leash are a constant cause of complaint in our community.

In the interests of public safety and community wellbeing, I would like to offer a friendly reminder that the Redlands values responsible pet ownership as well as supporting the rights of others who may be affected by straying and boisterous pets.

As a pet owner in the Redlands you are required to register your dog or cat at 12 weeks of age and have them microchipped.

Residents also cannot keep more than two dogs or two cats on any property, although a permit for a third dog or cat may be available on compassionate grounds.

Wandering cats can be quite a neighbourhood nuisance and it is important that cat owners understand that they have a responsibility to keep their pets confined to their properties at all times. Cats will hunt at night and can be very destructive in our natural environment.

However, they can be happily kept inside or contained if you provide the right environment, so check out Council's website at www.redland.qld.gov.au for advice. It's under "animals and pets". Enclosures are also widely available and provide a fun space for cats.

When it comes to dogs, it is noisy and unrestrained pets which cause the most concern.

Dog owners must keep their furry friend's barking to a minimum and walk their dog on a lead at all times, unless in a designated off-leash area.

While many owners may believe their dog is well trained, friendly and no problem when walking off-lead, other people can become concerned and even fearful in the presence of an unrestrained dog, even if it is small.

Remember to also pick up your doggie do when in a public place. On-the-spot fines do apply.

Remember, it is the obligation of owners to ensure their dogs do not attack or frighten people or other animals.

Council's animal management team is happy to help both pet owners and other residents with advice.

With our festive and holiday season fast approaching, the most important finish to every day is that we all get home safely. Please take note of our speed limits and take care.

Hooning such as street racing, burn-outs and other offences continue to be a problem. Dealing with this behaviour is the responsibility of police, who have suggested a number of ways for residents to report these offences:

- If life or property is in immediate danger or the event is time critical call Triple Zero (000);
- If it's non-urgent, not life threatening or there is little likelihood that the offenders are still in the area, call Policelink on 131 444;
- For hoon-specific information call 13HOON (13 4666), which goes to Policelink or report online; or
- Contact your local police station.

By calling police when you see such behaviour, the chances of catching the offenders increases.
