It will be staged from 4pm on Saturday, 6 December, at Capalaba Regional Park as part of Council's commitment to move the concert around the City. The line-up this year includes Luke Kennedy (2013 *The Voice Australia* runner-up), the wonderfully talented Naomi Price, and 10-year-old Redlands girl and *The Voice Kids* winner Alexa Curtis. They will join other home-grown up-and-coming stars, including Jal Joshua, Kiara Rodrigues, Allison Crane, Adeline Williams and Leah Lever in a spectacular program of Christmas fayourites.

Savings returned from tax repeal

Savings from the repeal of the carbon tax are currently being returned to residents via a refund on the current rates notices. The refund totals \$38,48.

The repeal of the carbon tax in July also means it will cost Council less to dispose of future waste, so commercial tip fees also have been cut.

As well as this immediate saving, Council will continue to identify other cost reductions from the removal of the tax and reinvest them into the

City in a bid to ease cost-of-living pressures.

The full extent of the repeal of the carbon tax is still working its way through the system and depends on suppliers passing on the savings to Council.

Your say on City Plan studies

Consultation on studies that will underpin the upcoming City Plan has provided Council with a broad range of views to consider. Thank you to all those who attended forums on land availability in our City and the draft economic development strategy or who visited us at shopping centre and library displays.

During the process there was a lot of interest in how Council interacts with the State Government on projects, infrastructure planning (particularly roads, rail and parking) and how population growth is managed, as well as environmental and social values and their management.

There was also wide-ranging feedback to the economic development forums, which are a part of City Plan.

Key areas of interest here included how the draft strategy will link with previous strategies, the role of the proposed Economic Development Committee, and how we can build on our preferred industries, such as tourism.

Formal submissions and responses to an online survey have provided further information to better understand community and business opinions on our local economy. Council will keep you up to date as the project proceeds.

Summaries of feedback from the two series of community forums are now available on the City Plan engagement website, as well as a wide range of background studies.

This site already has had about 15,000 unique visitors, and a growing number of registered users.

Portfolios realigned

Since 2013, Council's organisational restructure led to a situation where the Councillor portfolios no longer aligned with Council's new structure.

This resulted in a situation where some portfolio spokespeople had to consult with more than one member of the Executive Leadership Team and vice-versa.

To improve the effectiveness and efficiency of the portfolio system and better align it with Council's new organisational structure, a new system was adopted by Council with six portfolio chairs instead of 10.

As part of this process, I relinquished my portfolio responsibilities to allow for the more streamlined approach and to allow me more time to concentrate on the needs of my division.
