Hello and a big welcome to new residents of Alexandra Hills South. I hope you find my regular newsletters of interest.

#### 2007/08 Budget Report

On 2 July, Council's budget was brought down and some significant works will be built to improve our community infrastructure. I am pleased with these projects and look forward to their implementation during the year. I have included a comparison table on the following page for your information. Division 7 still remains the lowest general rate per household in the Shire.

#### Capital works

A total of \$128,000 has been approved for footpath/bikeway works throughout the division. I am also happy to announce that Redland Bay Road will receive \$70,000 in drainage improvements to the area east of the end of Vienna Road. Residents raised this particular problem with me and I am happy this will be resolved as it has been an issue for many years. A further \$25,000 will be expended on local area traffic management in the Division.

#### Park upgrades

\$50,000 will be provided from my Community Benefit Fund to improve facilities in several of our major recreational parks. This will include irrigation and seating to improve our play areas for both players and spectators alike.

**General rates** - Average general rate increase of 4%.

Access charge increased by 14.5% Water -

> Consumption charges per KL increased by 8.4% plus a change to the usage limits in the tier structure. However, if households reduce their consumption of 250kl/year to 210kl/year, the consumption component will increase by

4% from \$147.00 to \$153.00.

Wastewater -Waste -

Increase of 10.7% or \$57.50 to \$595 per year Increase of 4% to \$225.00 for basic domestic

charge.

Fees/Charges - General increase of RSC CPI (4.6%).
