

Tribute Plaque Application



Application Requirements

Application for a Tribute Plaque will be accepted provided the following information is supplied:

- ☐ The plaque will be placed on an existing identifiable park seat in the chosen location. Only one plaque is allowed per seat at this chosen location.
- ☐ Park standards & specifications will establish the type/style of seat provided for the attachment of the Tribute Plaque.
- ☐ Payment in full is received for the Tribute Plaque, on the basis that the plaque will be maintained for a minimum of 10 years (*but not exceeding 15 years*) in original location. A new application and further payment of a charge will be required after this time should another plaque be requested.
- ☐ The terms and conditions in the Council's "Tribute Park Seat, Tribute Plaque and Tribute Tree Guidelines GL-3004-004" will specify the terms and conditions for installing a Tribute Plaque.

Plaque Inscription Guidelines

Council does not allow memorial or commemorative plaques in any of its parks or on park furniture. Inscriptions on the plaque that indicate lifetime may not be used and wording must be in the present tense to keep the inscriptions uplifting, while still honouring the person who is being remembered by the Tribute Plaque.

The plaque is 50 mm high and 100 mm maximum length. This allows for a maximum of three lines and approximately 55 characters.

Tribute Plaque Charge \$280.00

The charge covers the cost of supplying and installing the Tribute Plaque. The charge also includes maintaining and repairing the plaque for a period of 10 years. Should the plaque, in the opinion of the Parks & Conservation Service Manager require complete replacement due to damage or vandalism during this time, it will be done at no additional cost to you.

Once the location of the plaque, the wording for the inscription has been finalised and full payment received, the plaque will be installed and confirmation provided that the installation has been completed. Direct payment can be made via the phone or in person at one of Council's Customer Service Centres after approval has been received.
