

# Tribute Park Seat Application



## Application Requirements

Application for a Tribute Park Seat will be accepted provided the following information is supplied:

- The park or open space in question has space, that there is an established need and is aesthetically acceptable for a seat to be installed in the chosen location.
- Park standards and specifications will establish the type and style of seat provided.
- Payment in full is received for the tribute park seat, on the basis that the seat will be maintained for a minimum of 10 years (but not exceeding 15 years) in original location. A new application and further payment of a charge will be required after this time should another seat be requested.
- The terms and conditions in the Council's "Tribute Park Seat, Tribute Plaque and Tribute Tree Guidelines GL-3004-004" will specify the terms and conditions for installing a Tribute Seat

## Plaque Inscription Guidelines

Council does not allow memorial or commemorative plaques in any of its parks or on park furniture. Inscriptions on the plaque that indicate lifetime may not be used and wording must be in the present tense to keep the inscriptions uplifting, while still honouring the person who is being remembered by the Tribute Park Seat. The plaque is 50 mm high and 100 mm maximum length. This allows for a maximum of three lines and approximately 36 characters or 12 words per line.

## Tribute Park Seat Charge

Mainland: \$3,138.50

Island: \$3,766.00

The charge covers the cost of supplying and installing the park seat, installing and engraving the plaque. The charge also includes maintaining and repairing the seat for a period of 10 years. Should the seat, in the opinion of the Parks and Conservation Service Manager require complete replacement due to damage or vandalism during this time, it will be done at no additional cost to you.

Once the location of the seat, the wording for the plaque inscription has been finalised and full payment received, the seat and plaque will be installed and confirmation provided that the installation has been completed. Direct payment can be made via the phone or in person at one of Council's Customer Service Centres after approval has been received.
