Head of Power

The *Local Government Act 2009* allows for the levying of utility charges and general charges.

The *Water Supply (Safety & Reliability) Act 2008* includes powers for regulating trade waste discharges to sewerage systems.

The Australian Wastewater Quality Management Guidelines 2022 provides a framework for managing wastewater to a sewerage system.

Policy Objective

To ensure the effective and sustainable management of commercial and industrial wastewater discharged into the sewerage system, in a way that safeguards public health, ensures employee safety, and aligns with Council's legal responsibilities and obligations.

Additionally, this Policy aims to establish a transparent framework for the application of Trade Waste related charges, as determined in the annual budget meeting, ensuring responsible and accountable financial contribution towards Council's wastewater management.

Policy Statement

Redland City Council is committed, as outlined in its Corporate Plan, to delivering services that realise our community's shared vision and collective aspirations *Naturally wonderful lifestyle. Connected community. Embracing opportunities.* As a values-led organisation, our core values guide our operations and support our mission: Make a difference, make it count.

Council is dedicated to developing, implementing and resourcing a Trade Waste plan in line with the *Water Supply (Safety and Reliability) Act 2008* which fulfils all Council's legal requirements and obligations under this Act. This plan will include: Adequate controls, systems, objectives, policy instruments and discharge standards consistent with the Australian Wastewater Quality Management Guidelines 2022, aiming to minimise environmental risks.

Recovering commercial and industrial service costs, including conveyance, treatment and sewerage system maintenance, by applying a fair, consistent and transparent Trade Waste charging methodology, aligned with the *Local Government Act 2009*, the Australian Wastewater Quality Management Guidelines 2022 and Council pricing models.
